Candidate: Christopher Chapman (MO) - incumbent

Category: Service Provider

Candidate Statement/Bio:

I wish to be considered as a candidate for a 2nd term on the NOWRA Board of Directors. I understand the commitment this role requires and look forward to fulfilling the expectations as a Board Member. My interest specifically lies in the area of Service Provider. I can offer years of experience and knowledge in this specialty area.

I received a Bachelor of Science in Business Administration with emphasis in Management and Marketing from Columbia College, Columbia, MO in 2008. I then continued my education in Soil Sciences at the University of Missouri under the guidance of Dr. Randy Miles and am now one of the top Soil Onsite Soil Evaluators in the state of Missouri for Onsite Waste Water Applications. After finishing my schooling and state certifications I began my company, Show Me Soils, specializing in soil evaluations for onsite systems in Franklin County and surrounding counties. We have now been serving our clients for the last thirteen years. Overall, I would estimate my years in the Onsite Wastewater in some capacity to be 27 years.

Candidate Statement/Bio

Candidate Statement/Bio

Thank you for considering me for the NOWRA board of directors' position coming up in 2024. I have read the elections overview information and understand the commitment to holding a board position. I am writing this letter to nominate myself, Brian Koski, for the installer board position opening.

I first started in the onsite industry in 2004 after completing an Associates' Degree in Water Quality Science. This 2-year program was focused on water and wastewater treatment and allowed me to obtain my water and wastewater operators licenses in 2005. Starting with an internship with Septic Check in 2004, I have stayed with the company ever since and eventually became sole owner of the company in 2013. Over my time with Septic Check I have obtained all onsite licenses available in Minnesota and have 20 years' experience in all of the disciplines including design, inspection, installation, service provider, and maintainer. I have been involved with our state organization, MOWA, since 2005 and have attended conferences and continuing education every year since. I have also served on the MOWA board for 2 terms, was president for 2 terms, and was also involved in many of the committee functions.

What specific area of interest do you desire to work with the NOWRA Board on industry issues and how you will make a contribution?

I enjoy leveraging my experience in the field as a professional and as a business owner to help other professionals in any way I can. Basically, I am happy to help anywhere I can provide the organization value. I have always been a forward thinker and mostly enjoy strategic thinking and creative problem solving. With that said, I think I can contribute to the board meetings discussions as well as some of the committees. I am also willing to serve on the executive committee if it makes sense to do so in the future.

Why you are willing to serve on NOWRA's Board as a leader in the onsite industry?

I enjoyed my time on the MOWA board and continue to enjoy being involved in leadership for our company and industry as a whole. I believe it is my duty to lead our industry by example through our daily work within our company and business. Operating our business with a high level of integrity and professionalism is the only way in my opinion to show our community we serve that our industry is a long-term solution for decentralized wastewater treatment.

What is your perspective(s) on the directions that NOWRA as an organization should consider in order to increase its leadership role in the industry?

The first thing that comes to mind for me is creating massive value for its members and stakeholders so that it cannot be ignored. Creating that value can be done in many ways, but probably starts with supporting state organizations, providing a voice at the regulatory and policy level, and creating a level of consistency across the industry through research, education, and code standards.

What are the critical issues that NOWRA's Board should be addressing on behalf of its members?



Some of the critical issues I see in Minnesota and surrounding states mostly revolves around regulation and the workforce. There has been a lot of turnover in the last 5-10 years in all disciplines which seems to have created an experience and knowledge gap. Attracting new, and retaining existing professionals, to the onsite industry seems to be a challenge for us and across all trades. Ultimately the onsite industry is competing with all other trades for a smaller amount of skilled professionals, so focusing on helping with this seems like a worthwhile pursuit.

A second issue I see is lack of consistency in regulation. At least in our state, application of the code is different at every LGU and the state level. I think some of this is due to lack of experience or knowledge as noted above. In my opinion, if we cannot rely on regulation for a benchmark, or know that our work is being reviewed with the same level of consistency and accountability as other areas, it is difficult to see how the industry as a whole can improve its reputation as a viable long-term solution.

Lastly, I think investing in research that can inform policy, training, and many other key industry areas should be heavily considered. If we are equipped with factual data, better decisions can be made, whether it's counseling policy makers and regulators, or training professionals.

Candidate: Tricia Scott (NE) - incumbent

Category: Regulator

Candidate Statement/Bio

I would like to formally declare my interest in re-applying for a position on the NOWRA Board as a representative of the regulatory community. I understand this three-year commitment means I will be required to attend at least one face to face meeting every year, attend monthly ZOOM meetings, and to read and review printed materials submitted to the board prior to meetings. Additionally, I will be a point of contact for other state regulators, as well as serving as a representative voice and mentor for the regulatory community in NOWRA matters.

I am a lifelong resident of Nebraska who grew up in a small town very close to the Wyoming border. I graduated from the University of Nebraska-Lincoln with a degree in geology. After college, I started working for the State of Nebraska in the Division of Weights and Measures. In 2014, I took a position with the Nebraska Department of Environmental Quality in their Field Services and Assistance Division. In 2016, I moved to the Onsite Wastewater Section, where I worked as a Staff Assistant until being promoted to an Onsite Wastewater Program Specialist in 2019. I have 20 years of experience working in state regulatory agencies, and eight years of experience working in onsite wastewater regulation. I am currently employed as an Onsite Wastewater Program Specialist for the Nebraska Department of Environment and Energy. In my free time, I enjoy writing, reading, and riding my moped.

What specific area of interest do you desire to work with the NOWRA Board on industry issues and how you will make a contribution?

The connections I have made during my term on the NOWRA board have been invaluable in learning more about how other states regulate onsite wastewater, as well as how other stakeholders, including service providers and installers, view and respond to their specific state's regulations. Being able to consult with and hear from leaders in all areas of the industry is helping Nebraska build a better, stronger Onsite Wastewater program in every aspect. Nebraska's aging, rural community who live on fixed incomes and have failing systems they cannot afford to replace is still a chief concern for our state. I am looking forward to working with



SORA and other groups and stakeholders to find innovative and sustainable ways to fund repairs and replacements for these systems.

Why you are willing to serve on NOWRA's Board as a leader in the onsite industry?

Taking a position on NOWRA's Board has allowed Nebraska to establish a nationwide network of leaders and professionals in the onsite industry to share knowledge and experience. Nebraska's Onsite Wastewater Section has experience developing an online system registration tool, working with local entities to achieve compliance, and resolving complex compliance issues. Through NOWRA connections, Nebraska has found more education opportunities for our certified professionals and a much greater understanding of the Onsite industry as a whole. By serving a second term, I hope to gain more connections in the industry and to deepen my knowledge base and experience. Having the amazing resource that is NOWRA available to us has given me many ideas that I can share with my program and Department, as well as the onsite community in Nebraska and beyond.

What is your perspective(s) on the directions that NOWRA as an organization should consider in order to increase its leadership role in the industry?

I am a firm believer that outreach and education are some of the most important functions leaders can provide. Informed, educated members of an industry are better prepared to identify issues and enact solutions. Knowing that they have a knowledgeable and accessible group of various members of the onsite wastewater community makes it easier to work cooperatively to create balanced and appropriate regulations and guidelines for safe, effective, and efficient onsite wastewater treatment systems.

What are the critical issues that NOWRA's Board should be addressing on behalf of its members?

The available pool of certified professionals who do onsite wastewater work is aging and retiring. The number of registered certified professionals has gone from stagnant to decreasing within the last four years in Nebraska. Many young people entering the workforce are unaware of the demand for onsite wastewater professionals and have little access to information about relative start-up costs to build an onsite wastewater business. Training classes are difficult to access or non-existent, especially in rural areas with poor internet access, though Nebraska is making strides in providing more training.

As concerns grow about the quality and availability of potable water, groundwater quality is more important than ever. Onsite wastewater treatment via traditional systems is not always viable due to soil types, setback distances, and environmental factors. More and more companies are proposing alternative treatment systems that need to be evaluated for efficiency and effectiveness. While a one size fits all approach to evaluation isn't feasible or desirable, some standardized guidelines for evaluation would be helpful, especially for regulatory agencies who may not have such processes in place.
